**Time Schedule of Ballot to determine priority of Members giving notice for moving motions for leave to introduce Private Members' Bills and for introducing Private Members' Resolutions.**

Members are hereby informed that the days allotted for transacting Private Members' Business are on 1<sup>st</sup>, 8<sup>th</sup> and 15<sup>th</sup> of November, 2019 as per the Calendar of Sittings of the Sixteenth Session of the Fourteenth Kerala Legislative Assembly. The Private Members' Business will come up in such a manner that the business relating to Private Members' Bills and that relating to Private Members' Resolutions shall be taken up for discussion on alternate Fridays commencing with the business relating to Private Members' Bills as per Direction No.15 of the Hon'ble Speaker dated May 10, 1993. As such, the business relating to Private Members' Bills will come up on 1<sup>st</sup> and 15<sup>th</sup> of November 2019. The relative precedence of Members entitled to move Bills on the allotted day will be determined by ballot. The last date for giving notice for Bills (with copy of Bills) and the date of ballot is as shown in the table below.

As per the Direction mentioned in pre-para, the business relating to Private Members' Resolutions will come up only on 8<sup>th</sup> of November 2019. The relative precedence of Members entitled to move resolutions on the allotted day will be determined by ballot.

The Members who secure the first three places in the ballot for resolutions may give notice for one resolution each.

The last day on which notice is to be given for including the names of Members in the ballot, the date of ballot and the date before which a Member who wins in the ballot has to give notice for the resolutions are as shown in the table given below.
